The Belvedere Club Terms and Conditions of Membership Agreement

This Application constitutes my request for membership to THE BELVEDERE CLUB. I understand that it will take approximately five to seven working days to process the application and that admittance to membership is subject to approval by The Italian Cultural Foundation at Casa Belvedere Board of Directors.

In consideration of THE BELVEDERE CLUB receiving and processing my request for membership, I acknowledge and agree any and all sums paid by me for or towards the initiation donation will be refunded only if my request for membership is not approved by the board of directors of Casa Belvedere, in which event all sums are to be refunded without interest. I further agree that, as a member of The Belvedere Club I shall be bound and will abide by Rules and Regulations in effect, and by any changes thereto that may be made in the future throughout the term of my membership.

Please initial:

- _____ I understand that my Italian Cultural Foundation at Casa Belvedere annual dues will be \$1,000 and will be billed on January 1st of each consecutive year that I remain a Belvedere Club member in good standing.
- _____ I understand that my Quarterly minimum spending requirement with The Belvedere Club will be \$400. There are 4 quarters in each year, beginning in January.
- _____ I understand annual dues and quarterly spend requirements may change with prior notice from Casa Belvedere and Belvedere Club management and that I may cancel my membership at any time, provided I give written notice to the membership department and have a cleared balance on my Belvedere Club account.
- _____ I understand that a valid credit card must be on file at all times and account balances 30 days overdue will be charged to my primary credit card on file.

I, _____, agree to abide by the following "Terms and Conditions" of The Belvedere Club Membership Agreement.

- A. This membership agreement shall entitle Member to be considered for membership privileges provided by The Belvedere Club. This Membership Agreement will not be acted upon unless (i) Member has been proposed and sponsored in accordance with the rules, (ii) this Membership Agreement is fully completed and executed, and (iii) this Membership Agreement is accompanied by payment in the amount of the Membership Donation of \$2,000, which shall be in United States of America ("U.S.") currency.
- B. Member acknowledges and agrees to be responsible for all charges incurred, which shall be due and payable no later than thirty (30) days from billing.

- C. Member acknowledges that membership is not an investment in The Belvedere Club or Owner, nor does it provide an equity or ownership interest in The Belvedere Club. The facilities of The Belvedere Club (the “Club Facilities”) are for recreational use only.
- D. Member acknowledges that a member only acquires a revocable license to use The Belvedere Club facilities in accordance with the rules and membership documents. The Belvedere Club reserves the right, at any time or from time to time, in its sole and absolute discretion, to reserve memberships, to discontinue operation of any or all of The Belvedere Club facilities, to sell or otherwise dispose of The Belvedere Club facilities in any manner whatsoever and to any person whomsoever, to terminate any or all types of membership, and to make any other changes in the terms and conditions of membership or use of The Belvedere Club facilities.
- E. Member covenants and agrees to indemnify and hold harmless The Belvedere Club, Owner, and their members, partners, shareholders, directors, officers, employees, representatives, affiliates, and agents in accordance with the provisions of the membership documents.
- F. Member acknowledges that use of The Belvedere Club facilities may be restricted from time to time based on events, construction, renovation, maintenance, and other causes. Owner shall have the right to offer other types of membership and dues categories from time to time, in owner’s sole and absolute discretion. The Belvedere Club, Owner, and their affiliates, agents, and assignees shall have the right to use The Belvedere Club facilities for all their business purposes and may designate certain other individuals or employees to use The Belvedere Club facilities. Such use may be at a reduced rate or complimentary basis.
- G. Member hereby acknowledges that The Belvedere Club and Owner may use photographs taken of member and other users at The Belvedere Club and statements made by any of them at The Belvedere Club for Club publications, without prior approval.
- H. Resignation is permitted only in accordance with the membership documents. Member acknowledges that the membership Donation and all other amounts must be paid in full prior to resignation of the membership. Member’s use and privileges as a member will continue until the membership terminates under the terms of the rules. Member, as a member, must continue paying all dues and other charges required until the membership terminates.
- I. Member agrees to abide by the dress code of The Belvedere Club as described in membership documents.
